The City of Rahway requires a Business Registration Certificate from the State of New Jersey before doing business in the city. You may also be required to obtain additional licenses or registrations depending on your specific type of business. Visit https://business.nj.gov/category/start for license/certification information.

Every business operating in the City of Rahway requires an approved zoning permit prior to opening. When a business is considering a location in the city, the first step is to determine whether the zone/location is approved for that type of business. For inquiries about permitted uses, you can call or email the Department of Engineering & Land Use at zoning@cityofrahway.com or 732-827-2181.

Zoning Permit Application & Instructions

The zoning permit fee is \$20.00. You can visit the Department of Engineering and Land Use located at 1 City Hall Plaza, 2nd Floor (building entrance is from the parking lot) to submit a Zoning Application and payment (cash/check). You can also download the Commercial Zoning Application from our website: www.cityofrahway.org/departments/engineering-land-use/division-of-land-use/

If you plan on making any changes or upgrades to the site, building or are doing any construction, electrical and/or plumbing work, engineering and or building permits are required and can be submitted at the time of submission of the zoning permit.

Zoning & Planning Board Reviews

If a commercial zoning permit is denied by the zoning officer, it can be appealed to either the Zoning Board of Adjustment or the Planning Board depending on the reason. Also, some businesses and site improvements may require planning or zoning board approval as well. If you plan to make changes to the building, signage, parking areas, ancillary buildings or structures, you may need to obtain a Site Plan Approval from the Planning Board. If any of the proposed business uses are not allowed per ordinance, applicants may apply for approval by requesting a use variance through the Zoning Board of Adjustment.

If no board review is necessary, the business owner will still need to submit architectural drawings to the Building Department and apply for the necessary building permits. There are fees associated with Planning Board and Zoning Board of Adjustment reviews. Both the Zoning Board of Adjustment and Planning Board applications can be found on the City of Rahway Website under Department of Engineering and Land Use, subsection Division of Land Use.



Construction

Construction permits are required for renovations, alterations, electric, plumbing, fire protection systems, and proposed changes of use.

The City of Rahway recommends that business owners contact the Division of Building for guidance with construction permit applications, and work with a New Jersey licensed architect if construction documents are required.

New Jersey State law requires architectural drawings for renovations or alterations to commercial spaces. Construction documents (i.e. blueprints) may be required depending on the scope of work. Electric, plumbing, HVAC, and fire protection systems must be done by New Jersey licensed contractors.

By state law, the Division of Building must adhere to the Uniform Construction Code (UCC).

The owner or contractor is responsible for obtaining a construction permit, and scheduling and passing all required inspections. Once passed, a Certificate of Approval for Continued Occupancy will be issued by the Division of Building. Signage / Window Displays / Lighting

A zoning permit is required to erect, install, paint, alter, relocate or change any signage on doors, windows, facades,

pylons, or awnings (fabric change or installation). A rendering of the sign should be submitted with the Zoning Application. Permits are issued through the Department of Engineering and Land Use and they will advise if the signage also requires a permit from the Division of Building.

Certificate of Occupancy/Change of Occupancy

If no construction or change of use is required, a business owner must apply for a Certificate of Approval for Continued Occupancy from the Property Maintenance Division at 732-827-2199 or propertymaintenance@cityofrahway.com



Food Establishments

Food-related businesses must adhere to strict requirements for construction and remodeling set by the State of New Jersey. The Department of Health requires and issues licenses for all restaurants and retail food businesses.

Food businesses must go through plan review with the Department of Health in addition to their Division of Building reviews and inspections.

Clean to Curb/Property Maintenance

Businesses within the Central Business District are asked to participate in the Clean to Curb Program. Clean to Curb is a business partnership to keep the sidewalks clean in front of establishments by regularly picking up wind-blown litter. Businesses also work together to make the downtown environment more pleasant by following garbage and recycling guidelines. Please keep your buildings and lots clean, safe and free of garbage, graffiti and debris. Any questions or ideas please contact the Rahway Department of Health at 732-827-2092. Any safety concerns or nuisances can be reported to the Police Department's non-emergency number 732-827-2200. (For emergencies call 9-1-1)

Garbage & Recycling

There are special requirements for garbage and recycling collection in the Central Business District. Contact the Public Works Department at 732-827-2060 for Solid Waste and Recycling Guidelines.

Vehicle Idling

New Jersey law limits the length of time a stopped motor vehicle can sit with the engine idling to 3 minutes. Violation is subject to a fine of a minimum of \$250. Delivery vehicle drivers should be made aware of this statewide regulation.
